CBD dosing recommendations vary; ranging widely depending upon the source referenced (from 0.02 mg/kg to 2 mg/kg). It is noteworthy that these doses are progresively coming down as more work is being done with CBD.

Orally, CBD is very poorly absorbed, demonstrating a normal oral absorption curve of only 4% to 12%. The "Functional Dose" successfully received at target receptors following absorption is therefore given in the 1st two columns in red.

This is in large part due to:

- (1) CBD's degredation in gastric acid,
- (2) CBD's significant First Pass Effect metabolism by the liver,
- (3) CBD demonstrates a Biphasic Dose Response Curve (meaning, more is not necessarily better).

Vediol contains 0.265 mg of CBD per drop, with approximately 1132 drops in a 2-ounce bottle (300 mg CBD/2-ounce bottle).

Because of the sophisticated technologies built into Vediol (backed multiple patents and patent pendings), gastric acid degredation is avoided, and First Pass Effect metabolism by the liver is bypassed for more effective absorption directly into the bloodstream. Thus, the absorption curve of Vediol is more in line with that which would be seen with inhalation and/or sublingual absorption routes of administration. Vediol has been built with science.
